Report of the Executive Director

February 23rd Consolidated Primary Report

Executive Director Bride informed the Board the final turnout was 16.57%. Forty percent of voters cast their ballots prior to Election Day. The Peoria Township Supervisor race is a two-vote difference. The losing candidate has 5 days after the last day to certify to request a discovery recount. The discovery recount can look at up to 25% of votes cast.

April 6th Consolidated General Report

Executive Director Bride told the Board that around 70 ballots have been mailed out to date to voter's outside the city limits. Early voting a vote by mail begins tomorrow for City of Peoria residents. There are around 2000 vote by mail ballots being mailed out tomorrow.
