The meeting was called to order at 2:00 p.m.

A Roll Call of the Commissioners was taken by Chairman Bartolo finding all Commissioners present except Commissioner Pinto.

Approval of Minutes

Vice Chairman Ketterer moved to approve the minutes for the March 11, 2021 Monthly Meeting. Secretary Manning seconded. Motion passed unanimously.

Approval of Expenditures

Executive Director Bride explained the bills (see attached) to the Board. Treasurer Burke moved to approve the bills. Vice Chairman Ketterer seconded. Motion passed unanimously.

Report of the Executive Director

April 6th Consolidated General Report

Executive Director Bride discussed the overall turnout for the election and reported he was pleased with the election overall. Vice Chairman Ketterer asked about turnout numbers for Early Voting and Vote by Mail. Executive Director Bride reported that about 1/3 of the voters voted before election day.

Discussion of 2021 Projects

a) Redrawing of precincts

Executive Director Bride told the Board that it was the responsibility of the Election Commission to draw new precinct boundaries after the other local jurisdictions (cities, counties, Peoria Park, Peoria Public Schools) have drawn their districts in an attempt to avoid splitting precincts.

b) Mailing of New Voter Registration Cards

Executive Director Bride explained that after new precincts are created, the office will be mailing all voters in Peoria County new voter registration cards.

c) Request for Proposal for Voting System

Executive Director Bride gave a timeline for the request for proposal for a new voting system. He told the Board that the plan is to release the proposal on June 1st. He stated this timeframe would allow plenty of time to acquire a replacement system. He said that he has started working on the request for proposal. Chairman Bartolo asked if the Board would be handling the RFP. Executive Director Bride explained that the Peoria County Purchasing Department will handle release and responses to the RFP but that he recommends a committee be formed to evaluate the responses, including staff and Board members, County IT and legal.
